THE VENETIAN MARCH HIGH HAND GIVEAWAY AND FREEROLL POKER TOURNAMENTS PROMOTIONS RULES

1. The Venetian March Cash Game Promotions consist of the March High Hand Giveaway and the March Freeroll Poker Tournaments (collectively "March Cash Game Promotions") and are for all contributing Texas Hold'em Poker Games.
2. Participating games include \$1-\$3 and \$2-\$3 No Limit Hold'em games and \$4-\$8 and \$8-\$16 Limit Hold'em games that are not a part of a Mix game and do not have a time collection for rake ("Participating Games.")
3. The March Cash Game Promotions are subject to The Venetian Poker Rewards Terms and Conditions and Venetian Rewards Terms and Conditions.
4. The Venetian Resort Las Vegas management reserves the right to cancel the March Cash Game Promotions, amend the March Cash Game Promotion rules, change the March Cash Game Promotion dates, or adjust the March Cash Game Promotion structures in its sole and absolute discretion without prior notice.
5. March Cash Game Promotion winnings are nonrefundable and nontransferable.
6. The Venetian Resort management reserves all rights. All disputes and subsequent decisions by management are final and binding.
7. Failure to adhere to The Venetian March Cash Game Promotion rules will result in disqualification and/or forfeiture of any winnings.
8. March Cash Game Promotion winnings will be paid from a promotional pool funded by The Venetian Promotional Progressive Pots and Pools, Drawings, and Giveaway Programs Rules ("Promotional Pool"). During the March Cash Game Promotions, the Promotional Fund drop per hand will be \$1 on the flop, with a second \$1 taken if/when the pot reaches twenty (\$20) total. See The Venetian Resort Promotional Progressive Pots and Pools, Drawings, and Giveaway Programs Rules for details.
9. Winner is responsible for paying any and all taxes and fees in connection with claiming any March Cash Game Promotion winnings.
10. The Venetian Resort management is not responsible for any computer malfunctions.

MARCH HIGH HAND GIVEAWAY

1. Beginning March 1 through March 31, 2026 ("Designated Dates"), each day, The Venetian Poker Room will award the player with the highest qualifying hand in any participating game a High Hand Giveaway of two hundred dollars (\$200). The Qualifying Period will begin at 10:00 a.m. on March 1, 2026, and continue every thirty (30) minutes until 1:30 a.m. daily on the designated days ("Qualifying Periods"). The player to achieve the highest hand in each Qualifying Period will be paid two hundred (\$200) in Casino Chips ("High Hand Giveaway"). The Qualifying Period and hands reset every thirty (30) minutes. The last Qualifying Period will be from 1:30 a.m., and the final payout will be at 2:00 a.m. daily.
2. Winner is permitted to add any portion of the High Hand Giveaway to their current chip stack. Once one (1) hand is played after Winners receive their High Hand Giveaway, standard table stakes rules apply.
3. To qualify for the High Hand Giveaway, a player must show a hand that is stronger than the currently posted High Hand. Only a full house or higher will qualify. The current qualifying hand may be announced and/or posted.
4. To be considered part of a Qualifying Period, a qualifying hand must be tabled by the player, and the hand must be complete prior to that Qualifying Period ending. Otherwise, if applicable, the hand will be considered part of the next Qualifying Period.
5. It is the player's responsibility to alert the dealer of a qualifying High Hand during any Qualifying Period. Any potential High Hand that is not brought to the attention of the dealer or a supervisor during the Qualifying Period for which the hand was tabled will result in that High Hand being null and void. The player who had the potentially winning High Hand will forfeit any portion of the High Hand Giveaway for the Qualifying Period in dispute.

6. Any player who is deemed by poker management to intentionally stall playing their hand in order to progress their potential high hand to the next Qualifying Period leaderboard may have their potential high hand disqualified, may be asked to leave the poker room for the day, and may have their playing privileges revoked altogether. These concerns should be brought forth by players to poker management in real time so we can investigate, monitor, and resolve as needed to protect the integrity of the promotional pool.
7. There must be at least a minimum of four players dealt in at the beginning of the hand in order to qualify for the High Hand Giveaway.
8. A qualifying hand can use any five card combination, provided they use both cards in their hand. It doesn't need to be the best five card hand. The player must win the entire main pot for which the qualifying hand was dealt.
9. In the event that there are no qualifying hands during a Qualifying Period, then there will be no Winner for that High Hand Giveaway, and the funds will remain in the Promotional Pool.
10. Winner must be present at the conclusion of the Qualifying Period. If Winner is not present, the High Hand Giveaway will be forfeited. Forfeited High Hand Giveaways will remain in the Promotional Pool.
11. Winners must present a valid ID and a Venetian Rewards card to collect the High Hand Giveaway. High Hand Giveaway will be forfeited if Winner refuses to provide a valid ID and a Venetian Rewards card. Forfeited High Hand Giveaways will remain in the Promotional Pool.
12. If Winner is willing but unable to produce a valid ID and a Venetian Rewards card at the conclusion of the Qualifying Period, they will have seven (7) days to claim the High Hand Giveaway at the Poker Room Cage. High Hand Giveaway will be forfeited if Winner does not provide a valid ID and Venetian Rewards card within seven (7) days. Forfeited High Hand Giveaways will remain in the Promotional Pool.

MARCH FREEROLL POKER TOURNAMENTS

1. The March Freeroll Poker Tournaments will consist of four (4) individual qualifying Promotional Periods and Freeroll Poker Tournaments ("Promotional Period").
 - a. The first qualifying Promotional Period will be from February 28, 2026, at 12:00 a.m. through March 6, 2026, at 11:59 p.m. Any player who logs thirty (30) hours of participating promotional cash game hours during the Qualifying Period will be qualified to participate in the Freeroll Poker Tournament. Any player who plays a promotional eligible cash game between the hours of 2 a.m. and 7 a.m. daily will earn 1.5 hours of play time for every hour played that is then applied towards the Freeroll Promotion thirty (30) hour minimum requirement. The Freeroll Poker Tournament for this Qualifying Period will take place on Sunday, March 8, at 10:10 a.m. This Freeroll Poker Tournament will award a minimum of thirty thousand (\$30,000) dollars in prizes that will be determined and posted prior to the start of the tournament on March 8, 2026, based on the number of players who are qualified to participate.
 - b. The second qualifying Promotional Period will be from March 7, 2026, at 12:00 a.m. through March 13, 2026, at 11:59 p.m. Any player who logs thirty (30) hours of participating promotional cash game hours during the Qualifying Period will be qualified to participate in the Freeroll Poker Tournament. Any player who plays a promotional eligible cash game between the hours of 2 a.m. and 7 a.m. daily will earn 1.5 hours of play time for every hour played that is then applied towards the Freeroll Promotion thirty (30) hour minimum requirement. The Freeroll Poker Tournament for this Qualifying Period will take place on Sunday, March 15, at 10:10 a.m. This Freeroll Poker Tournament will award a minimum of thirty thousand (\$30,000) dollars in prizes that will be determined and posted prior to the start of the tournament on March 15, 2026, based on the number of players who are qualified to participate.
 - c. The third qualifying Promotional Period will be from March 14, 2026, at 12:00 a.m. through March 20, 2026, at 11:59 p.m. Any player who logs thirty (30) hours of participating promotional cash game hours during the Qualifying Period will be qualified to participate in the Freeroll Poker Tournament. Any player who plays a promotional eligible cash game between the hours of 2 a.m. and 7 a.m. daily will earn 1.5 hours of play time for every hour played that is then applied towards the Freeroll Promotion thirty (30) hour minimum requirement. The Freeroll Poker Tournament for this Qualifying Period will take place on Sunday, March 22, at 10:10 a.m. This Freeroll Poker Tournament will award a

minimum of thirty thousand (\$30,000) dollars in prizes that will be determined and posted prior to the start of the tournament on March 22, 2026, based on the number of players who are qualified to participate.

- d. The fourth and final qualifying Promotional Period will be from March 21, 2026, at 12:00 a.m. through March 27, 2026, at 11:59 p.m. Any player who logs thirty (30) hours of participating promotional cash game hours during the Qualifying Period will be qualified to participate in the Freeroll Poker Tournament. Any player who plays a promotional eligible cash game between the hours of 2:00 a.m. and 7:00 a.m. daily will earn 1.5 hours of play time for every hour played that is then applied towards the Freeroll Promotion thirty (30) hour minimum requirement. The Freeroll Poker Tournament for this Qualifying Period will take place on Sunday, March 29, at 10:10 a.m. This Freeroll Poker Tournament will award a minimum of thirty thousand (\$30,000) dollars in prizes that will be determined and posted prior to the start of the tournament on March 29, 2026, based on the number of players who are qualified to participate.
- e. A total of one hundred twenty thousand (\$120,000) dollars will be awarded during our March Freeroll poker tournaments. The Venetian Poker Room reserves the right to award additional prize money each week based on the total number of qualifying players at our sole and absolute discretion.

2. Players who are qualified to participate in any of the four (4) Freeroll poker tournaments on March 8, 15, 22, and 29, 2026, and who fail to show for the Freeroll Poker Tournament for which they qualified, will not be eligible to receive any prize money.
3. Venetian Rewards members qualify for the March Freeroll Poker Tournaments based on total active cash game play in participating games at The Venetian Poker Room during the Promotional Period ("Active Play").
4. Hours of Active Play are tracked through the use of a Venetian Rewards card and are non-transferable. Players who play without using a Venetian Rewards card will not have their Active Play tracked. Venetian Rewards members are responsible for using their Venetian Rewards card to ensure Active Play is tracked.
5. Venetian Rewards members are responsible for ensuring they remain logged in to the table and for verifying the accuracy of their play. At the completion of every Promotional Period, each Venetian Rewards member's Active Play will be calculated to ensure they have met the thirty (30) hours of required promotional cash game play in order to be eligible for that Qualifying Period's Freeroll poker tournament.
6. The top ten (10) players who earn the most promotional eligible cash game hours weekly from; 12:00 a.m. until 11:59 p.m. during the following Qualifying Periods, February 28-March 6, 2026, March 7-13, 2026, March 14-20, 2026, and March 21-27, 2026, will receive a three hundred (\$300) bonus payout. A total of \$3,000 will be paid each weekly Qualifying Period for a total bonus payout of twelve thousand (\$12,000) dollars in March. All bonus payouts will be paid out of the promotional pool. To receive the \$300 bonus payout prize, the players must register and participate in the Freeroll poker tournament for which they have qualified. Any player who earned a bonus prize and does not participate in the Freeroll poker tournament will forfeit their \$300 cash prize bonus payout. All forfeited bonus payouts will remain in the promotional pool.
7. Once weekly on Saturdays, the Venetian Poker Room will post how many Venetian Rewards members have qualified during the Promotional Period for the Freeroll poker tournament for that week. Names will be withheld.
8. Qualification for each Freeroll Tournament is unlimited to the amount of players who may qualify. No additional players may register or qualify for the Freeroll Tournaments once the Promotional Qualifying Period has ended for that week.
9. Registration for the Freeroll Tournaments will be every Sunday between 9:00 a.m. and 10:00 a.m. Qualifying Venetian Rewards members must register in person and sign confirming registration. The participants are responsible for having a valid ID and Venetian Rewards card at the time of registration; otherwise, they will not be permitted to register for the Freeroll Tournament for which they have qualified. Qualifying Venetian Rewards members who do not register for the Freeroll Tournament by 10:10 a.m. on the Sunday for which they have qualified will not be permitted to participate in the Freeroll Tournament. Any player who fails to register for the Freeroll Tournament by 10:10 a.m. will not be eligible for any prize money.

10. Qualifying Venetian Rewards members who register for the Freeroll Tournament will be required to pay a \$30 Buy In at the time of registration. Qualifying Venetian Rewards members who do not pay the \$30 Buy In will not be registered for the Freeroll Tournament and will not be eligible for any Prizes. \$200 of all Buy In money collected will be used to fund the two hundred (\$200) cash prize for the last place finisher in the Freeroll poker tournament. All other Buy In money will be withheld as a staff fee gratuity.
11. Every Sunday, as per the schedule above, at 10:10 a.m., the Freeroll Tournament will begin. All qualifying Venetian Rewards members who registered for the Freeroll Tournament will have their chips put into play at the start of the Freeroll Tournament.
12. All registered qualifying Venetian Rewards members who participate in the Freeroll Tournament will win a Prize worth at least \$200. Please see The Venetian March Freeroll Tournament structure sheet for applicable tournament rules, structure, and prize distribution.
13. Winners will have seven (7) days to claim their Prizes. Winners must provide a valid ID and Venetian Rewards card in person and will be subject to federal guidelines for W-2G or 1042S reporting. Prizes will be forfeited if the Winner does not provide a valid ID or Venetian Rewards card within seven (7) days, refuses the Prize, or refuses to fill out reporting paperwork. Forfeited Prizes will remain in the Promotional Pool.
